

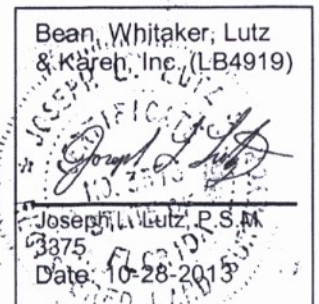

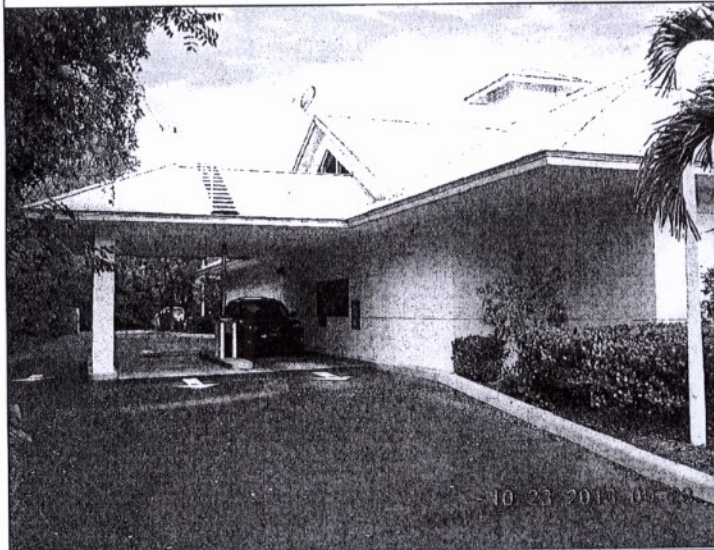
Front view



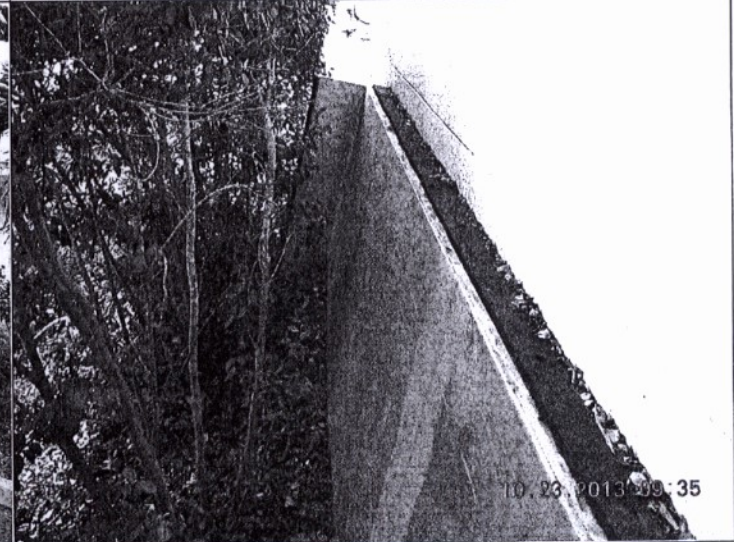
Side view
