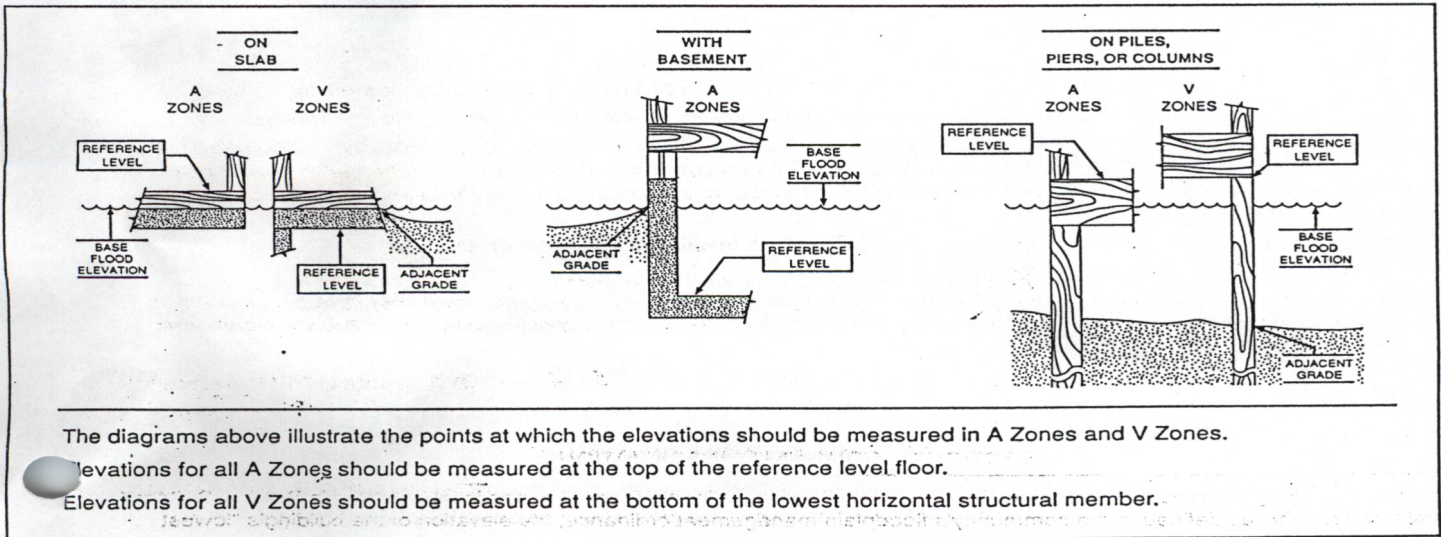

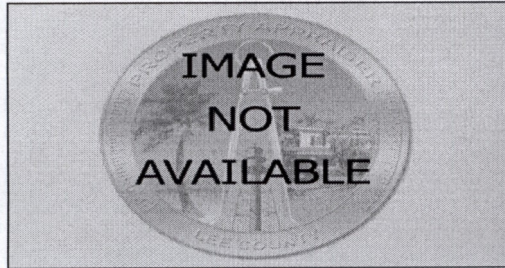


Image of Structure
